- (11) Motion made by Commissioner Nichols, seconded by Commissioner Hanna and unanimously adopted by the Court designating polling places for run-off election in the Republican Primary.
- (12) Motion made by Commissioner Sanchez, seconded by Commissioner Hanna and unanimously adopted by the Court exempting certain vehicles in the sheriff's office [Patrol Sergeant's vehicle, Mental Health vehicle and Investigator's vehicle] from the inscription requirements.
- (13) Motion made by Commissioner Sanchez, seconded by Commissioner Nichols and unanimously adopted by the Court awarding bid for paving the Sports Complex West Parking at the ballparks to Permian Paving Inc. [21,000 square footage at \$2.75 equals total bid price of \$57,750.]
